Foreword

Grants, both originating from domestic as well as external sources of fund, are every state revenue in various forms obtained from development partners. Grants is one amongst various sources of development funding with the most flexible characteristic, where there is no requirement for the Government to return the given fund, unlike that in foreign loan schemes. According to Article 41 of the Regulation of the Minister for National Development Planning/Head of the National Development Planning Agency Number 4/2011 concerning Procedure for Planning, Proposing, Assessing, Monitoring, and Evaluation of Projects Financed by External Loan and Grants, Grants must be used to support national development programs, natural disaster resilience, and to perform humanitarian assistance. Grants also needed to be in accordance with national development goals as stated in the Medium-Term National Development Plan (Rencana Pembangunan Jangka Menengah Nasional/RPJMN) 2020 - 2024. Noting the provision, and also the fact that the opportunities for Indonesia to receive the Grant has been very limited currently due to the economy's improvement, hence grants must be utilized optimally. It has therefore been administered through a rigorous planning process under the coordination and supervision of Ministry of National Development Planning/The National Development Planning Agency (Bappenas), as the main agency responsible for national development planning. The planning process results in an annual planning document for grant projects called List of Planned Grant Projects or Daftar Rencana Kegiatan Hibah (DRKH).

For the year of 2023, DRKH 2023 is enacted through the decree of Minister of National Development Planning/Head of National Development Planning Agency (*Bappenas*) number KEP. 153/M.PPN/HK/12/2023 on List of Planned Grant Projects (DRKH) Year 2023 (*Daftar Rencana Kegiatan Hibah Tahun* 2023). It consists of 4 projects in 4 ministries with the total grant amount of USD 45.7 million. The document reflects that the 2023 grants are used to contribute in health program, to support external loan's proposed activities in public transportation sectors, and in gender equality project.

With the enactment of this document, it is expected that ministries/agencies whose proposed projects are listed in the DRKH 2023 could use this document as a guidance to prepare the implementation of the grant projects. This document is guidance for line ministries in preparing grant projects so that the result can be utilized to boost the achievement of national development targets as next year will be a crucial year in achieving the targets of RPJMN 2020-2024.

Chapter 1

1. Introduction

According to the Government Regulation Number 10/2011 on Procedure for the Procurement of External Loans and Grants, Indonesian Government could receive grants to support national development programs, handle the impact of natural disasters, and to perform humanitarian assistance. In order to utilize this source of financing, *Bappenas* issues an annual planning document for grants called List of Planned Grant Projects or *Daftar Rencana Kegiatan Hibah* (DRKH) is issued. This document contains project proposals which are eligible to be funded by grants, namely those which are considered to have fulfilled the readiness criteria required, as well as already have funding indications from perspective donors.

The DRKH 2023 is enacted through the decree of Minister of National Development Planning/Head of National Development Planning Agency (*Bappenas*) number KEP. 153/M.PPN/HK/12/2023 on List of Planned Grant Projects (DRKH) Year 2023 (*Daftar Rencana Kegiatan Hibah Tahun* 2023).

The document is presented in two chapters. Chapter 1 consists of the recapitulation of the projects by line ministries and the list of projects along with an indication of its source of financing. Whilst Chapter 2 presents the digest for each grant project, containing a summary of the project information such as its location, scope, outputs and outcomes as well as institutions involved in project implementation.

2. Recapitulation and List of Projects in DRKH 2023

The DRKH 2023 consists of 4 proposed projects from line ministries with the total grant amount of USD 45.7 million and the total local cost amount of USD 10 million. The grant which is received by the Indonesian Government this year are used to contribute in health program, to support external loan's proposed activities in public transportation sectors, and in gender equality project. Most of these proposed grants are from multilateral and bilateral development partners

The list of projects in the DRKH 2023 as stipulated in the Ministerial Decree of National Development Planning/Head of National Development Planning Agency Number KEP. 153/M.PPN/HK/12/2023 is shown in Table 1.

6. Background and Justification

The INEY phase 2 program includes a grant component through the Investment Project Financing (IPF) instrument of US\$30,5 million to provide catalytic technical assistance (TA), capacity building, and M&E support to the ministries/agencies responsible for DLI achievement. The inclusion of the IPF component serves to align the financing of development partners, namely GFF and the Gavi Alliance, in support of the GoI program and PforR. The GFF funding aims to help Indonesia maintain essential health and nutrition services and enhance service quality and system resilience in the face of COVID-19 pandemic. The Gavi grant will sharpen the focus on immunization within the stunting reduction program, with a specific emphasis on increasing imunization coverage for children under five years of age. The IPF component will also support to complement the GoI's own arrangements for PforR operationalization. The World Bank will also sustain Bank-executed, grant-financed technical assistance to support the implementing agencies to achieve their contribution to the national strategy.

The program will finance similar activities across sub-components including: individual consultants and firms to provide secretariat support and technical assistance to the implementing agencies, including environmental and social, financial management, and procurement assistance; consulting firms to support capacity building activities, such as development of tools for effective deployment or training at subnational level (such as learning modules, hands on support for district offices and villages for rollout and use); consulting and non-consulting services for the development and implementation of performance systems; consulting firms to support development and piloting of innovative digital technology systems and tools; individual and firm consultancies to carry out field data collection, data analysis and analytics, process evaluation, and learning; small

office equipment and supplies; and operational costs of meetings, workshops, training, travel, and program supervision.

In each stage, the focus of the reform area is improvement of policies, tools, and capacity building of key government officials. 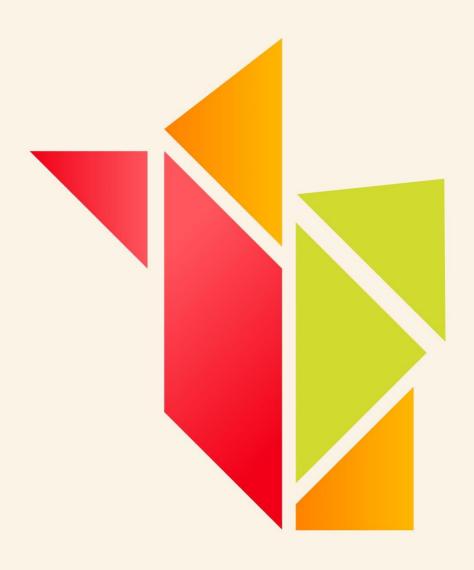
